## HOW WE STARTED

There has always been a need to focus on the topic of Officer Safety since the first documented Code Enforcement Officer murder in 1932 when the profession was just establishing itself.

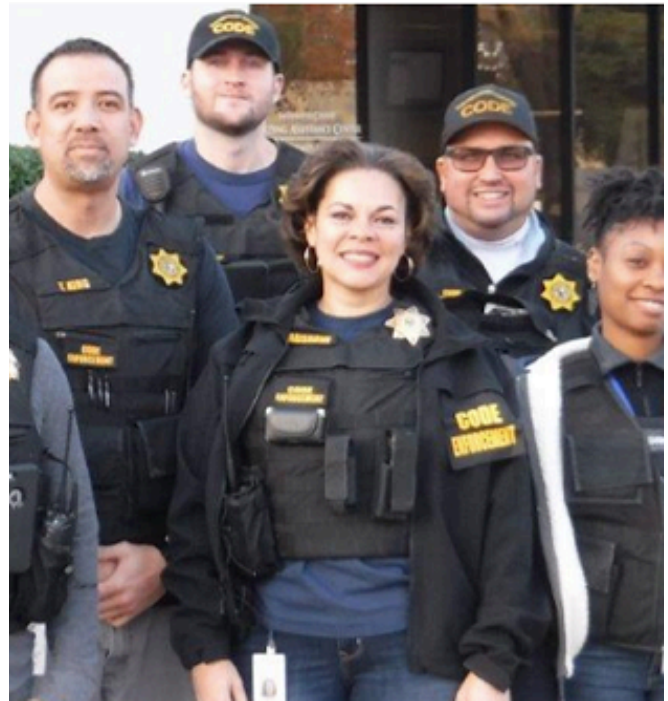
In 2018, Code Enforcement Officer Jill Robinson from Utah was murdered at an inspection and tragically set on fire. Why? She was the officer assigned to a nuisance case at the property and was meeting with him to seek a resolution. Code Enforcement Officers across the country have been murdered for just doing their job of regulating health and safety. Since Jill's murder, three (3) other Officers have been murdered.

In 2018 Timothy Sun started an Officer Safety Fund to raise money to donate bullet-proof vests in honor of Jill. Then in 2020, Justin Edson started a national tracking website and memorial page. The Foundation was formed in 2020 when all of these resources merged together. The Foundation provides resources, information, a newsletter, statistics, and scholarships reliant on generous donations.



# WHAT IS A CODE ENFORCEMENT OFFICER

Code Enforcement Officers are called a variety of terms throughout the country and between different jurisdictions. They could be called officers or inspectors and can be assigned to Building Departments, Community Development, Fire, or Police. In some jurisdictions, Code Enforcement Officers are Peace Officers assigned to enforcing housing and nuisance laws. In other areas they are assigned to the Fire Department as Fire Marshals or inspectors. The Foundation also represents Building Inspectors, Fire Inspectors, Health Inspectors, Animal Control, CSO's, Vector, Park Rangers and all Code Officials.
